

APCI FCU Online Service E-Sign Disclosure and Consent

This Online Service E-Sign Disclosure and Consent ("**Disclosure**"), applies to all communications ("**Communications**") for those products and services offered through our APCIRCUIT® PC Home Banking Service (APCIRCUIT) and APCI eMobile Banking Service (APCI eMobile). From time to time, we may amend these terms and modify or cancel services we offer without prior notice to you, except as may be required by applicable law. Your continued use of the Online Services shall indicate your acknowledgment, agreement and acceptance of any changes to this Disclosure and/or the applicable products and services.

Definitions

As used in this Agreement, the following terms have the following meanings:

- "**Account(s)**" means your eligible APCI FCU share savings, share draft checking, loan, and other APCI FCU products that can be accessed through APCIRCUIT;
- "**You**", "**Your(s)**", and "**Member**" mean each person with authorized access to your Account(s) who applies and uses APCIRCUIT; and
- "**APCI FCU**", "**We**", "**Our**", "**Us**" and "**Credit Union**" means APCI Federal Credit Union.

Scope of Communications to Be Provided in Electronic Form

When you use a product or service to which this Disclosure applies, you agree that we may provide you with any communications in electronic format, and that we may discontinue sending paper communications to you, unless and until you withdraw your consent in the manner set forth herein. Your consent to receive electronic communications and transactions includes, but is not limited to:

- All legal and regulatory disclosures and communications associated with the product or service available through APCIRCUIT and APCI eMobile for your Account(s);
- Notices or disclosures about a change in the terms of your Account(s); and
- Privacy policies and notices.

Method of Providing Communications to You in Electronic Form

All Communications that we provide to you in electronic form will be provided, free of charge, either: (1) via email; or (2) by access to a web site that we will designate in an email notice we send to you at the time the information is available.

How to Withdraw Consent

You may withdraw your consent to receive communications in electronic form at any time by selecting that option under "eAlerts", which is accessible from your APCIRCUIT account homepage by clicking on the "Settings" link. No fees will be imposed to process the withdrawal of your consent to receive electronic communications. Any withdrawal of your consent to receive electronic Communications will be effective only after we have a reasonable period of time to process your withdrawal.

How to Update Your Records

It is your responsibility to provide and maintain a current email address. APCI Federal Credit Union (APCI FCU) is not responsible for any undeliverable notices due to factors beyond our control such as system failures or misdirected email delivery due to reasons such as inaccurate information. You can update information (such as your email address) under "Update Contact Information," which is accessible from your APCIRCUIT account homepage by clicking on the "Services" link.

Hardware and Software Requirements

In order to access, view, and retain electronic Communications that we make available to you, you must have a computer or device that meets the minimum system requirements.

In the event APCI FCU must change the minimum hardware or software requirements needed to access or retain electronic records, you may receive a statement containing the revised hardware and software requirements for access to and retention of electronic records. In such event, you have the right to withdraw consent (in the manner set forth above) without the imposition of any fees for such withdrawal.

Requesting Paper Copies

We will not send you a paper copy of any Communication, unless you request (in accordance with this Section) it or we otherwise deem it appropriate to do so. You can obtain a paper copy of an electronic Communication by printing it yourself or by requesting that we mail you a paper copy, provided that such request is made within Seven (7) business days after we first provide the electronic Communication to you. To request a paper copy, please contact one of our Member Services Representatives at 800-821-5104.

Communications in Writing

All Communications in either electronic or paper format from us to you will be considered "in writing." You should print or download for your records a copy of this Disclosure and any other Communication that is important to you.

TRANSMITTAL OF ELECTRONIC STATEMENTS

By clicking on the “I Agree” button below and electing to receive your statements electronically, you:

- Acknowledge you have read and understand the APCI FCU (“**Credit Union**”) Online Statement Access Agreement (“**Agreement**”);
- Agree to accept your APCI FCU periodic statements, and all disclosures related to your statements, electronically by a visual text to be displayed on a personal computer monitor ;
- Request that your eStatement Availability Notice be transmitted to you electronically; and
- Agree to the terms and conditions set forth in this Agreement.

Definitions: As used in this Agreement, the following terms have the following meanings:

- “**Account(s)**” means your eligible APCI FCU share savings, share draft checking, loan, and other APCI FCU products that can be accessed through APCIRCUIT® PC Home Banking Service;
- “**You**”, “**Your(s)**”, and “**Member**” mean each person with authorized access to your Account(s) who applies and uses APCIRCUIT; and
- “**APCI FCU**”, “**We**”, “**Our**”, “**Us**” and “**Credit Union**” means APCI Federal Credit Union.

Your consent to receive your eStatements electronically applies only to your periodic Account eStatement and related disclosures. The Credit Union will include ‘Your Billing Rights’ notice with each periodic statement.

You acknowledge and agree that by requesting your Account statements be delivered electronically, you will not receive paper statements in the mail. However, this Agreement does not affect your right to receive a paper statement. A fee may be charged to print a prior statement. Following eStatement activation and the closure of your next periodic statement cycle, a Credit Union eStatement Availability Notice will be sent to the email address you provided. Once enrolled you will be able to access up to twenty-four (24) months of account history.

You acknowledge and agree that if the Credit Union has reason to believe that the transmission of your statements electronically is no longer viable or that any such transmission may give rise to security or operational concerns, the Credit Union may without notice cease the electronic delivery of your statements and provide you with paper statements. You acknowledge that:

- Any email address you provide to the Credit Union is accurate;
- You will promptly notify the Credit Union, by signed letter mailed or faxed to the Credit Union, of any change in your email address. You may also update your email information within APCIRCUIT PC Home Banking Service;
- You have a computer that meets the minimum system requirements; and
- You have a printer or have access to a printer with the ability to download information in order to keep copies of your statements for your records.

You may un-enroll from the eStatement process, free of charge, at any time by faxing to: 610-841-2588 or 610-841-2589 or mailing to: PO Box 20147, Lehigh Valley, PA 18002-0147 a signed request to the Credit Union.
